



WHO:

DROM, INC. is as an agency licensed by the state of Maryland to provide community residential services, Personal Support an Respite services to individuals with intellectual and other development disabilities.

WHAT:

DROM, INC. provides Residential Support Services to individuals with intellectual and other development disabilities to live independently in the community.

RESPITE is a DDA funded program that assists individuals with disabilities in all aspects of their live except vocational services. I is a Short-term, temporary care provided to an individual in their home or outside their home.

Respite may be just a few hours or several days in length depending on the plans of the care giver.

Respite may be planned in advance or may be available to assist in a crisis/emergency situation.

WHERE:

Individuals who have full eligibility may receive respite in any of the settings listed below the individual's home.

Or at any of our licensed homes in the counties we provide residential services. DROM provide services in Prince George's, Baltimore, Frederick, Carroll and Montgomery Counties.

SCOPE

RESPITE SERVICES

RESPITE is a DDA funded program that assists individuals with disabilities in all aspects of their while in a residential placement. It is a Short-term, temporary care provided to an individual in their home or outside their home.

It is designed to give the primary caregiver (s) a break from their care giving duties.



Respite may be just a few hours or several days in length depending on the plans of the caregiver.

Respite may be planned in advance or may be made available to assist in a crisis/emergency situation.

We provide services such as money management, home management, nutrition, meal preparation, obtaining resources in the community, taking consumers to medical appointments, parenting skills, getting involved in leisure activities, as well as aspects of living on their own.
